TEMPORARY TRAFFIC ORDER
3/137 WYCK RISSINGTON TO WYCK ROAD (WYCK RISSINGTON PARISH)
COTSWOLD DISTRICT ORDER 2019

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for the 3/137 Wyck Rissington to Wyck Road from 400 metres North West of property known as number 1 Wyck Rissington to outside property known as number 20 Wyck Rissington for a distance of approximately 1072 metres ("the Road") is satisfied that use of the Road should be prohibited because works are being or are proposed to be executed on or near it.

NOW THEREFORE the Council in exercise of its power under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984, as amended, hereby makes the following Order:-

1. Except for pedestrian access to properties, no person shall proceed nor cause or permit any vehicle to proceed along the Road;
2. The Road falls in Wyck Rissington Parish in the Cotswold District and in the County of Gloucestershire;
3. This Order shall come into operation on the 7th day of January Two Thousand and Nineteen and shall continue in force for a period not exceeding eighteen months;
4. This Order May Be Cited As "Gloucestershire County Council Temporary Traffic Order 3/137 Wyck Rissington to Wyck Road (Wyck Rissington Parish) Cotswold District Order 2019".

TEMPORARY CLOSURE OF 3/137 WYCK RISSINGTON TO WYCK ROAD (WYCK RISSINGTON PARISH) COTSWOLD DISTRICT

Gloucestershire County Council has made an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close part of the 3/137 Wyck Rissington to Wyck Road from 400 metres North West of property known as number 1 Wyck Rissington to outside property known as number 20 Wyck Rissington for a distance of approximately 1072 metres.

The reason for the closure is to replace water mains and associated fittings and services.

Pedestrian access will be maintained. Emergency access will not be maintained as the road will become too narrow for vehicles to pass safely.
